Ph.D. Admission 2026-27

Applications are invited from the eligible candidates for admission to Ph.D. in Pharmaceutical Sciences and Ph.D. in Computer Engineering, Information Technology, Artificial Intelligence & Machine Learning, Data Science, Civil Engineering, Mechanical Engineering & Electrical Engineering.

Eligibility:

The applicant must have a Master's Degree or a Professional Degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 10-point scale subject to clearance of SNGU PET (Entrance Test).

Steps of admission/selection process:

- Application in prescribed Format * SNGU PET (Entrance Test) *Personal Interview *Merit List

Application Process:

- Interested applicants may apply by paying an application fee via the official website of SVKM NMIMS Global University at www.svkmmimsgu.ac.in
- The application fee would be Rs. 1000/- (Non-Refundable).

SNGU PET:

- SNGU PET Examination will be conducted at SNGU, Dhule Campus, in person
- The admit card will be sent to an eligible candidate on the registered email address in advance
- The applicant must have qualified SNGU PET with qualifying marks as 50% in each paper (I&II)
- The exam will be conducted for two papers as described below

Exemption from SNGU PET:

- Applicants who have qualified NET/ GATE (Engineering Aspirants) & GPAT/GATE (Pharmacy Aspirants) examinations with valid periods and scores are exempted from SNGU PET.
- If a candidate's claim for exemption from the SNGU PET is rejected, they would be informed in advance to appear for the SNGU PET.

About the Personal Interview:

- SNGU PET/NET/ GATE (Engineering Aspirants) & GPAT (Pharmacy Aspirants) qualified applicants will be called for the personal interview.
- The call letter will be sent on the registered email address in advance

Merit List:

- The merit list will be declared based on performance in the SNGU PET and Personal Interview.
- The weightage for admission is as follows: SNGU PET/Qualifying Examination: 70%, Personal Interview: 30%.
- For candidates who are exempted from the SNGU PET, the merit will be declared based on Qualifying Examination & Personal Interview.

Terms:

- Applications found incomplete or received after the prescribed date will be rejected. No inquiry /correspondence from such candidates shall be entertained.
